A LETTER FROM CEO JAN GLICK

It is with great pride that we look back on the accomplishments

of Big Brothers Big Sisters in this multi-year report as our small way of celebrating these achievements with our volunteers, donors, and advocates.



Three years ago, we went through a national rebrand and emerged from this experience with a newly articulated core belief: Together, We

are Defenders of Potential. It is through this lens that we are rethinking how our values and actions are contributing to true diversity, equity, and inclusion in our programs and community.

To this end, in 2019, we began the essential work of internal reflection and conversations with our staff, Board members, and external stakeholders to draft a Justice, Diversity, Equity, and Inclusion (JEDI) plan. Together, we are examining how we can evolve to better serve our Littles, Bigs, staff, and supporters, specifically our communities of color and culture.

We continue to be recognized as one of the leading agencies among the Big Brothers Big Sisters affiliates nationwide, in part due to program expansion without compromising quality. We have expanded mentor 2.0 from Pittsburgh Brashear High School to two additional community high schools, Cornell and Charleroi. These three programs served more than 300 youth last year.

Our Bigs in Blue mentoring programs have also grown, serving children throughout Allegheny County. We are grateful to the police officers who strongly believe in our mission and the possibility of changing the trajectory of law enforcement and child relationships in the region. We launched a Sports Buddies program to help recruit mentors that will reduce the number of boys on our waiting list. Sports activities are planned each month, helping volunteers to engage with their Littles in innovative spaces where they find common ground. This program is providing young people with unique sports experiences that promote physical and emotional health, the adoption of a healthy lifestyle, and a sense of community.

Even the strongest among us have been tested by the hardship and uncertainty of the past 18 months, so just imagine what navigating the hardships of COVID-19 has meant for the historically underserved youth we serve. During this challenging time, we have been comforted, encouraged, and humbled by the outpouring of generosity and support from our community. Remarkable people, organizations, community groups, small businesses, and corporations have all stepped up to support our one-to-one mentoring programs. Our mentoring relationships have withstood the pandemic, with strict adherence to all health and safety standards and protocols.

To us, YOU are our champions, and we thank you for helping us meet the challenges we face by helping us provide our services with integrity, compassion, accountability, respect, and excellence.

This is my last Annual Report message, as I will be retiring at the end of November. My journey, like all of life's journeys, has been marked by challenges, struggles, accomplishments, and successes. But the overall trajectory of our journey has been positive, making Big Brothers Big Sisters a healthier, stronger, more robust organization, as we continue to work tirelessly to ensure all children in southwestern Pennsylvania reach their full potential.

HIGHLIGHTS

Justice, Equity, Diversity, and Inclusion: Big Brothers Big Sisters of Greater Pittsburgh is committed to promoting the values of justice, equity, diversity, and inclusion (JEDI) and anti -racism throughout our organization. Over the past year, BBBSPGH has developed and promoted policies and programs that provide equal access and opportunity for organization volunteers, families, supporters and staff; and that values the diversity of every member of our community.

mentor2.0 Expansion: This past year, BBBSPGH launched our innovative mentor2.0 mentoring program at two (2) new high schools in our region – Charleroi High School and Cornell High School. This program combines the power of BBBS one-to-one mentoring with an evidence-based high school graduation success curriculum, and an on-line messaging (email) platform to improve academic performance, increase non-cognitive skill development, and to help students create a plan for their futures.

Virtual Mentoring Program Development: This year BBBSPGH created and launched a new series of virtual events and activities designed to engage matches during the pandemic.

Professional Development and Training for Mentors and Staff: In 2020, BBBSPGH expanded our workshops and training for staff and Bigs around trauma-based care, to help support our Littles and their families during the pandemic.



BIG & LITTLE BROTHER OF THE YEAR

In November of 2010, Eric walked into BBBSPGH's offices with his Aunt Rosalyn as a shy, 7-year-old boy who was grieving the loss of his father. Today, this 6'5" young adult is taking on the world by attending college with a dream of becoming an educator.

Mark, a young new employee at PNC had a new-found passion for corporate philanthropy and volunteerism and had recently decided to become a Big Brother with BBBSPGH. Eric and Mark's first meeting that day changed the trajectory of both their lives forever.

Eleven years later – with weddings, graduations, births, deaths, and during COVID – Eric and Mark continued to build their relationship. From attending football games, sporting events, and "Take your Father to Work Day" - to weekly phone calls to share successes and challenges, this mentoring relationship gradually turned into a brotherhood. According to Eric, Mark consistently put in the time and effort and never steered away from tough conversations. Despite their differences in age, race, and culture, Mark was always open to learning about Eric's world. He listened, demonstrated respect, and didn't make promises he couldn't keep. Mark invited Eric to be one of his groomsmen in his wedding – a day Eric will never forget.

According to Eric's Aunt Rosalyn, Mark has had a significant positive impact on Eric's life. Mark helped Eric develop into a kind, thoughtful and humble young adult, who always thinks of others before himself. Eric knows that Mark will always be there for him to offer guidance and encouragement when needed. Last year Eric lost his uncle to COVID, and Eric knew that Mark was just a phone call away to help him through it. It is nearly impossible to think of what Eric's life would be like today without the support of Mark. We can't wait to see what this brotherhood will bring to both of them in the future!

DONG & ALLY THEIR RELATIONSHIP IS THE DEFINITION OF "EMPOWERING POTENTIAL".

Although Dong and Ally have only been matched for one-year, their relationship is the definition of "empowering potential". What makes their bond special is that they were matched during COVID and began their relationship entirely online using technology.

Dong's family came to the United States from Vietnam when she was only three-years old, determined to make a better life for Dong and her siblings. Attending Pittsburgh Brashear, Dong was referred to BBBSPGH's mentor2.0 program because her family was not familiar with the education system in the United States and she was struggling to navigate the complexity of high-school and prepare for post-secondary schooling.

Aly has been Dong's ultimate cheerleader – helping her believe in herself and that her future does not have to be defined by her past. With Aly's encouragement and support, she took a rigorous load of AP classes during her senior year, joined the school's tennis team, became a member of Brashear's National Honor Society, and learned to build positive relationships with her peers and teachers, seeking out new challenges and opportunities. In every conversation between this match, Aly helped Dong develop her strengths and passions, and pushed her to use them to make positive changes in her own life and in her community. Dong and Aly are continuing in our newly launched mentor2.0 post-secondary school program that is following the chosen career/employment paths of ten Pittsburgh Brashear students who graduated from the program in 2021.

Aly and Dong met in-person for the first time on the campus of the University of Pittsburgh, where Dong will begin pursing her engineering degree this Fall. Beginning this Fall, we know that what started out as a "virtual" mentorship will continue into a life-long friendship!



BIG IMPACT

Over the past year, our Littles reported their mentors had a big impact in the following areas:

85% OF LITTLES RATED THEIR RELATIONSHIP WITH THEIR BIG AT LEAST A 4 ON A 5 POINT SCALE 92% **OF LITTLES** PLAN ON GRADUATING HIGH SCHOOL, WITH 68% **PURSING A** POST -**SECONDARY** SCHOOL PATHWAY

70% **OF LITTLES** REPORTED THAT THEY DID NOT ENGAGE IN BULLYLING **OR RECEIVE** SCHOOL DISCIPLINE
